SUBJECT: 1 Year Waiver Requirements for SY: 2020-2021, Attendance Procedures

The following information has been provided from USBE to address the online learning/hybrid model of teaching. This waiver has been approved for PHA for 1 school year only to address the length of time and how many days students receive instruction.

180 day/990 Hour Requirements and Learner Validation Enrollment:

- 1 year waiver has been extended to all schools operating an ONLINE and/or HYBRID program to be:
 - o 180 days of instruction
 - 990 hours of educational services
- Assurances were submitted to provide students quality instruction through blended learning and establishing norms for formative/summative assessments

Tracking Student Participation in the new COVID era:

- In-Person Learning:
 - Daily attendance checks ensuring attendance is entered into ASPIRE every Friday by PLC meeting
- Online Learning:
 - Tracking Attendance
 - Online Unexcused Absence: Student participating during Online days do not attend scheduled courses. Make up work may be available upon Teacher discretion.
 - Online Tardy: Student participating during Online days enter into session 10 mins after beginning of class session. Make up work maybe available upon Teacher discretion.
 - Online Disengaged: Students may log into Online session but do not participate in discussion or active learning. Make up work maybe available upon Teacher discretion.
 - Online Tech Issues: Student unable to attend Online sessions due to technical difficulties. Make up work maybe available upon Teacher discretion.
 - Online Excused Absence: Parent has communicated with teacher for Online session they will not be participating due to: illness or death in the family. Make up work will be available for all excused absences.
